Ronald McDonald House (RMH) is the cornerstone program of Ronald McDonald House Charities of Central Florida (RMHCCF). The Ronald McDonald House program provides a home away from home for families with seriously or chronically ill, or critically injured children being treated at pediatric hospitals in Orlando.

Form 990, Part III, Line 4a, Program Service Accomplishments:

Charities, along with other gifts, including new beds from Temper Pedic, were secured by the end of 2018, allowing us to move forward to update both RMHs in 2019.

It is of the utmost importance to our Children's Charity to continue to deliver high standards of quality, cleanliness, friendliness, security and safety within our overall RMH program. Funds provided by AbbVie in 2018 helped with the phase 2 expansion of the RMH on the campus of Nemours Children's Hospital along with the conversion of a gathering room for an additional bedroom at our RMH on the campus of Advent Health. A grant from Dr. Phillips Charities helped support the refurbishment of the RMH on the campus of Arnold Palmer Medical Center.

We were successful in completing and opening phase 2 of the expansion at our RMH on the campus of Nemours Children's Hospital while completing the heavy lifting of the refurbishing project in November

With the growth of our operations - serving 84 families and children each night, our RMH on the campus of Nemours Children's Hospital (24 bedrooms), our RMH on the campus of Arnold Palmer Medical Center (37 bedrooms) and our RMH on the campus of Advent Health (23 bedrooms), it was imperative that we completed both the expansion and refurbishing projects in 2019 to focus 100% on our operations budget while continuing to build on the financial sustainability of the Organization.

Implementing best practices learned from our third RMH build and the evolution of medical treatments, our refurbishing plans focused on uniformity - all colors, furnishings, textile products, bed sizes, light fixtures, etc., in an effort to be most efficient in our daily operations: maintenance, housekeeping, laundry, inventory, and ordering. All wallpaper was removed, new, smaller-scaled and same-finished furniture replaced the mix-match of pieces. Tempur-Pedic replaced all 99 all-size bed mattresses to queen size mattress with an in-kind gift. Bathroom fixtures and toilets were upgraded, etc. at both RMH's. Our property reserve covered the remainder of the refurbishing project cost, along with help from generous in-kind donors: Tempur-Pedic donated all the beds, Lazy-Boy provided chairs, Ferran donated services for plumbing installation - just to name a few.

The healing through art project - project 2020, was introduced the later part of 2018. The charity began recruiting local artists interested in participating in the collaboration with room donors to

create unique and original pieces of artwork for the 70 bedrooms being built or refurbished. Due to the scope of the art project, it was broken down into three phases, with the final phase being planned for spring 2020 with an open house and art viewing at each of the two houses.

We served 2,391 families in 2019. We remained opened throughout the refurbishment, working with as little disruption as possible. We maintained a working operation, closing only a few bedrooms throughout the refurbishing. We operated at 76.6% occupancy, full-occupancy most nights.

We are tracking housekeeping and maintenance efficiencies in an effort to continue to improve cost savings as part of refurbishing goals.

We enhanced our giving programs, providing more opportunities for friends and supporters to get engaged with our Organization. We increased our Cornerstone Society Donations by 2.6%. Increased our adopt-a-room program from 43 to 49 annual commitments. Our key initiative group had their most successful year ever - raising more than \$118,000. We brought back our Appetite for the Arches Gala that had been on hiatus for two years due to the capital campaign fundraising. We raised over \$180,000 in its first year back.

The first RMH in Central Florida opened in December 1996 on the campus of Florida Hospital for Children with 13 bedrooms. We expanded to 22 bedrooms in 1998. The second house opened on the campus of Arnold Palmer Children's Hospital in 2003 with 22 bedrooms. In 2006, we

expanded to provide 37 bedrooms. With the opening of our third Ronald McDonald house and the 2nd phase expansion, we now serve 84 families each night.

We have a Ronald McDonald house on each of the three pediatric hospital campuses in Orlando, just minutes, door to door, from house to hospital. Each of the houses offer a welcoming, comforting, clean, and safe environment. Each house provides a bedroom and a private bath, with 24-hour access to a fully furnished kitchen and pantry, dining room, gathering rooms, laundry facilities, and computers. The houses provide a wonderful place for families to sit and talk and share their stories. Although the illnesses of the children vary from neo-natal to pediatric cancer, and many, many more - one thing each family has in common and can share with one another is the worry, concern, and love of their child. They support one another.

A staff member is on site 24-hours a day, 7 days a week, 365 days a year. Volunteers assist staff from 9 am to 9 pm with three, four-hour shifts each day. They help with chores, answer phones, assist families checking in and out, and most importantly, they are there to support families in their toughest of times. They provide the listening ears and strong shoulders whenever needed.

The only requirements to stay at the RMH's in Orlando are to complete an application with a referral from the child's physician and to complete a background check for approval. There is no cost to families. We receive approximately 2.5% of our revenue from family donations.

Through 2019, we have served more than 32,000 families from 67 countries, 50 states, and 67 counties in Florida. 45% of our families come from Central Florida. The highest number of families come from the following five counties; Brevard 18%, Volusia 9%, Lake 6%, Orange 4% and Osceola 4%.

More than 12,000 volunteers work in the houses, assist with special events, help with community projects, and cook meals throughout the year, donating more than 33,000 hours to help provide support and comfort to our families in medical crisis.

Volunteers from corporations, civic organizations, and community groups participate in our share-a-meal program throughout the year. Lunch and dinner is served each day at all three RMH's. Volunteers come to the houses with groceries they purchase and prepare meals for our families. At noon and again at 6:30 p.m. each day, families know that there will be a nutritious, home-made meal waiting for them. They do not have to worry about having to fix a meal or clean up, they can return to the hospital again to visit their child.

An extension of our Ronald McDonald house program is our RMHCCF Family Gathering Room outreach program within the pediatric hospitals. The RMHCCF family room at Arnold Palmer Hospital is located on the fourth floor. The family gathering room provides comfortable chairs to rest or watch television, a kitchen/dining area for snacks or playing cards or games, a computer station for communicating with family and friends, and a shower, to freshen up after long hours at the hospital. Family Gathering Room was created for local Orlando families who may not need the Ronald McDonald house as a home away from home, yet, need the comfort and care of the program while they are in medical crisis. The outreach program has received positive and grateful responses from families and hospital staff.

We have expanded our snack pack program and comfort cart offerings to all families staying at the Ronald McDonald Houses, utilizing our RMHCCF Family Gathering Rooms, and/or have a child being treated within the pediatric hospitals. The snack packs provide nutritional treats for families during the long days by their children. The comfort kits offer toiletries and gifts of comfort to help with their long stay.

We encourage our community to get involved with our programs. Our staff and volunteers offer house tours on a regular basis. Appointments are requested, and can be arranged through our volunteer team or house staff. A tour of the house allows supporters to see firsthand our needs and helps provide opportunities to individuals, organizations, and companies to best align with their interests and expertise.

In 2019, supporters provided over \$550,000 worth of in-kind goods and professional services to our Children's Charity.

The Central Florida community has embraced the Ronald McDonald house program and its purpose; keeping families close, providing comfort and care to families who are going through the toughest of times, the illness of their child. The Ronald McDonald house serves families who
