Ronald McDonald House (RMH) is the cornerstone program of Ronald McDonald House Charities of Central Florida (RMHCCF). The Ronald McDonald House program provides a home away from home for families with seriously and chronically ill, or critically injured children being treated at pediatric hospitals in Orlando.

Form 990, Part III, Line 4a, Program Service Accomplishments:

We were operating at full occupancy, serving 84 families per night. Our share-a-meal program was booked months in advance for volunteers to cook meals at all of our houses. Our Annual Appetite for the Arches was almost sold out by the end of February and we were ahead of the financial goal with many sponsors already committed for support throughout the year.

On March 6, 2020, we were notified that COVID-19 was spreading rapidly and we needed to rethink our business model to accommodate for the children and families who were currently staying in our houses, as well as how we were going to move forward. On March 12, 2020, a mandate was sent down from RMHC global to immediately cease accepting new families until further notice. We reached out to the CDC and our three pediatric hospital partners to set up communications as we navigated the unknown of COVID-19 together.

As an organization, our number one priority was the health and well-being of our families and staff. We remained focused on that commitment.

Daily and twice-daily calls were set up among the staff. Zoom was no longer a novelty - it was the norm. Operation staff went into full disinfectant mode. Our kitchen and all gathering areas were shut down and blocked off to families until further notice. Thermometers, sanitation gels, masks, and all PPE resources were expedited to the houses. Volunteers were contacted to let them know not to report. Staff began to prepare meals while restaurants and grocery stores were recruited to ensure our families would be provided meals. All office staff were sent home to work remotely.

Throughout the month of March, occupancy rates began to drop. The families we were serving were leaving as their children were being released from the hospitals. The census at the hospitals were dropping with the hold on elective surgeries, and travel becoming almost non-existent. However, we did know there were still a few families who needed our services more than ever. We teamed with our hotel partners to negotiate rates for our Organization to continue to underwrite stays for those families who needed RMH. Our staff delivered meals, snacks, and comfort kits daily to the families at the hotels to continue to deliver our mission.

The first of July, COVID-19 cases spiked in our market and it was discovered in our houses. At that point, our RMHCCF Board of Directors made the difficult decision to temporarily close our houses (the first

time in our 23 year history) for the health and safety of our families and staff members.

We created a detailed reinstatement plan to help ensure all protocols and guidelines were being followed as to how and when we were bringing new families into the houses, utilizing hotels and all other resources, to continue to operate with the highest level of safety measures in place as possible.

We reopened all three Ronald McDonald Houses mid-August bringing new families in at a 25% capacity rate.

Overall, with all the fear, anxiety, and unknown that 2020 brought to the world, we are proud as an Organization - our number one priority always was and continues to be - the health and well-being of our families and staff. Our families, staff, Board of Directors, and donors remained strong, persistent, and supportive.

We ended up finishing project 2020, along with many other tasks. We completed our new website with a virtual tour, updated policy handbooks, completed a volunteer training video, implemented our events (virtually and reengineered), and introduced a new Hospitality Cart program.

We served 951 families (in the RMH's and in hotels), provided three meals a day to all families and exceeded our 2020 budget goal. Our RMH program still does not look the same as a year ago, however, we are currently operating at 50% occupancy, (a reflection of the hospital's

lower census during the pandemic) and our commitment to the mission continues.

We look forward to 2021 and the opportunity to share our history with the community as we celebrate our 25th anniversary in Central Florida. Looking back will help rejuvenate and reconnect us as we revisit our past and reengineer for our future.

Our history begins with the first RMH in Central Florida opening on December 13, 1996 on the campus of AdventHealth for Children (at the time Florida Hospital for Children) with 13 bedrooms. We expanded to 22 bedrooms in 1998. The second house opened on the campus of Arnold Palmer Children's Hospital in 2003 with 22 bedrooms. In 2006 we expanded to provide 37 bedrooms. With the opening of our third Ronald McDonald House and the 2nd phase expansion, we now serve 84 families each night.

We offer a Ronald McDonald House on each of the three pediatric hospital campuses in Orlando, just minutes, door to door, from house to hospital. Each of the houses offer a welcoming, comforting, clean, and safe environment. Each house provides a bedroom and a private bath. Although the illnesses of the children vary from neo-natal to pediatric cancer, and many others - one thing each family has in common and can share with one another is the worry, concern, and love of their child. They support one another.

A staff member is on site 24-hours a day, 7 days a week, 365 days a year. They are there to assist and support families during their

toughest of times. They provide the listening ears and strong shoulders whenever needed.

The only requirements to stay at the RMH's in Orlando are: 1) to complete an application with a referral from the child's physician and 2) to complete a background check for approval. There is no cost to families. We receive approximately 2.5% of our revenue from guest family donations. (During COVID-19 we have added screening requirements regarding travel and current health conditions.)

Through 2020, we have served more than 33,000 families from 67 countries, 50 states, and 67 counties in Florida. 51% of our families come from Central Florida. The highest number of families come from the following five counties: Brevard 20%, Volusia 8%, Lake 7%, Orange 4% and Osceola 5%.

Before COVID-19, over 12,000 volunteers worked in the houses, with special events, community projects, and others cooking meals throughout the year, donating more than 33,000 hours to help provide support and comfort to our families in medical crisis.

Volunteers from corporations, civic organizations, and community groups participated in our share-a-meal program throughout the year. Lunch and dinner was served each day at all three RMH's. Volunteers came to the houses with groceries they purchased and prepared meals for our families. At noon and again at 6:30 p.m. each day, families knew that there would be a nutritious, home-made meal waiting for them. Although the share-a-meal program does not exist as it once did, our donors and

staff continue to provide meals to our families. Supporters have underwritten meals from local restaurants for delivery to the houses, donated gift cards to restaurants and local grocery stores, and McDonald's owner/operators have contributed product for our staff members to use to prepare casseroles and other comfort foods for the families when necessary. Families do not have to worry about cooking or cleaning up, they can immediately return to the hospital to visit their child.

We have expanded our snack pack program and comfort cart offerings to all families staying at the Ronald McDonald houses, utilizing our RMHCCF family gathering rooms, and/or have a child being treated within the pediatric hospitals. The snack packs provide nutritional treats for families during the long days by their children. The comfort kits offer toiletries and gifts of comfort to help with their long stay.

We look forward to the day that we can, once again, invite our community back into the houses to tour, volunteer, and share their talents. Until that time, we encourage you to go to our website www.rmhccf.org - take a virtual tour of our houses, find out what events are happening and how you can get involved. Join our Cornerstone Society or adopt-a-room - support family stays, donate snacks, or other in-kind items. The Ronald McDonald Houses are made of brick and mortar, however, we call each of them the house that love built, because it is all the time, talent, and treasure of the Central Florida Community who help to serve the children and families in need.
