to implement all our in-person events as planned due to COVID, we were
able to tell our story, highlighting our milestones utilizing social
media and support from our media and mission partners. Each month we
focused on a different aspect of the charity's growth, such as the
opening of our three RMHs - one on the campus of each of the three
local pediatric hospitals in Orlando. The first House was built on the
campus of AdventHealth for Children (Florida Hospital at the time) and
opened on December 13, 1996, with 13 bedrooms (expanded to 23 in 1998).

recognized the resolute staff members who provided the comfort and care each day, and we celebrated McDonald's Owner/Operators and all our generous stakeholders who gave their time, talent, and treasure to make the Ronald McDonald House program a reality for the community.

We entered 2021 with cautious optimism. Although COVID cases were decreasing, we continued to follow the protocol from our learnings in 2020. We remained steadfast in our efforts to care for as many families as possible who came to the Ronald McDonald House in need. We moved forward with a phased approach - operating between 50-70% occupancy levels, as well as working with local hotels for any overflow or unprecedented circumstances. We served 1,165 families- who stayed an average of 12.4 days in 2021, compared to 951 families averaging 10.5 days per stay (during COVID) in 2020 and 2,391 families at 8.7 days in 2019.

Our volunteer program opened at reduced numbers for both in-house and events. Our Share-A-Meal program remained internal with a handful of volunteers and staff members preparing dinners from donated food and gift card contributions. Local restaurants supported us with premade meals throughout the year, and we collaborated with Second Harvest Food Bank, purchasing meals at a reduced price several times a week. We were able to provide our families three meals a day with the help of our generous community. Protocols did bring new opportunities. We were able to introduce the Ronald McDonald House Hospitality Cart into two of the hospitals. The cart, decorated as a fun and friendly Ronald McDonald House, visited the pediatric units with necessities, gifts, and snacks for the children and families. Our Gathering Room at Arnold Palmer

Hospital remained opened as a respite for families - although, at limited times and occupancy.

Once again, we assessed each line item in the budget with emphasis on the property reserve and in-kind opportunities moving forward with two aging Houses and increased capacity to our overall RMHCCF programs. We were successful in completing our refurbishing of the RMH on the campus of AdventHealth, as well as the RMH on the campus of Orlando Health. All bedrooms at both Houses were updated with standardized and streamlined dcor, while extending the art project to every bedroom to complete a calm and comfortable feeling for families. New and uniform furniture, updated bedding, fresh paint, and light and toilet fixtures have brightened and enhanced both Houses. Improvements including refreshed landscape, irrigation maintenance, and lighting were also completed in 2021.

We continued to focus on diversifying and increasing our revenue streams. Individual giving was our number one priority, capitalizing on the tools and resources we invested in throughout the years. We enriched our giving programs, providing more opportunities for friends and supporters to become engaged with our organization. We increased our Cornerstone Society donations by 200 and increased our Adopt-A-Room program to 61 from 57 annual commitments, while enhancing our direct mail strategy. Our key initiative committee continued to expand its reach, developing young leaders, and engaging them with RMHCCF while having fun raising funds. Our Appetite for the Arches Gala was revamped in 2021 to provide two separate evenings - one in the spring and the other in the fall, both held outside for safety measures. The two

events proved successful, exceeding the goal, as did all others that we were able to hold. We moved to outdoor venues - retooling each event.

Overall, the organization landed financially healthy, exceeding the budget goal by \$1.2M.

After 25 years of capital campaigns to build capacity to meet the needs of our growing community, the organization is debt-free at the end of 2021. This milestone enables RMHCCF to concentrate on the next phase of the organization's lifecycle - expanding reach, while enhancing the individual and planned giving programs while building an endowment to guarantee the long-term health and sustainability of the charity.

2022 will be the year to rebuild our successful programs. We look forward to opening our Houses to 100% capacity, welcoming back our volunteers, our Share-A-Meal providers, and a full-staff to continue to deliver our RMHCCF mission.

Moving forward, the priority of the organization is to continue to provide three Ronald McDonald Houses, just minutes door-to-door, to all pediatric hospitals in Orlando. Each House offers a caring staff around-the-clock to welcome families to a comfortable, clean, and safe environment with a bedroom and a private bath, 24-hour access to a fully stocked kitchen and pantry, dining room, gathering rooms, laundry facilities, and computers. Although the illnesses of the children vary from neo-natal to pediatric cancer, and many, many more, one thing each family has in common, and can share with one another, is the worry, concern, and love of their child; they support one another within the Ronald McDonald House.

We will also focus on expanding the Family Room and Hospitality Cart

programs into other markets of Central Florida. These programs will allow RMHCCF to serve more families in the nine outlying markets of Central Florida, providing a respite for families during their long day(s) within the hospital. Through 2021, the organization has served 36,000 families from 67 countries, 50 states, and 67 counties in Florida. Forty-seven percent (47%) of our families come from Central Florida. The greatest number of families in 2021 came from the following five counties: Brevard, Volusia, Lake, Marion, and Osceola. Expansion of RMHCCF programs will help provide family-centered care to those that are not in need of a Ronald McDonald House yet need a respite while their child is in medical crisis and being treated at the local hospitals.

We encourage our community to get involved with our programs. Our staff and volunteers offer House tours. A tour of the RMH allows supporters to see firsthand, the importance of our mission.

The Central Florida community has embraced the Ronald McDonald House program and its purpose; keeping families close for more than 25 years - providing comfort and care to families who are in medical crisis and going through the toughest of times, the illness of their child. The Ronald McDonald Houses are built of brick and mortar; however, we call each one of them the house that love built, because of the time, talent, and treasure of the Central Florida community, which helps to serve the children and families when they need us most - the illness of their child.

We look forward to another successful 25 years with expanded reach of
